**ART CRITERIA**

Art Gallery 21 accepts inquiries for submissions of all fine art media including oil, watercolor, pastels, acrylics, mixed media, photography, and collage. Maximum size of two-dimensional art is 36 inches in height (not including frame). Work must be clean, in sturdy condition, and wired for hanging (No Saw-tooth Hangers). All protected artwork must use Plexiglas, NOT glass. Unframed works on canvas must be finished on sides with no staples showing. 75% of art exhibited must be available for purchase.

**ART TAGS**

Artists are required to provide tags to accompany each art work submitted for exhibition. Each art work must be labeled on the back of the art as well. Below you will find the specs and format for the wall art tags. (Use a "sans serif" font such as Arial, Helvetica or Univers.)
