Maximum size of two-dimensional art is 30-inches in either direction (not including frame). Maximum weight 20 pounds. **Work must be clean and wired for hanging** (No Saw-tooth Hangers). All protected artwork must use Plexiglas, NOT glass. Unframed works on canvas must be finished on all sides with no staples showing.

Sculptures may be accepted. The gallery has a limited number of exhibit bases and acrylic covers.

All Broward County artists are invited to participate. Art must be original, not a copy of another artist's work. No nudes, please. **ENTRY FEE: \$20 per entry, maximum of 2 entries per artist.** We accept cash or checks payable to Art Gallery 21, Inc. All proceeds go to support the gallery's programs and projects. Please be advised that there are no guarantees of acceptance into the exhibit and there are no entry fee refunds.

EXHIBITION & AWARDS

A guest jurist will select the art entries that will be accepted into the exhibit and the three prize winners. Cash awards and ribbons will be announced live in the gallery on Saturday, September 16, 2023 at approximately 6 PM. Artwork will be hung in the gallery through October 14, 2023, and will be shared on our social media platforms. Gallery hours are Friday and Saturday from 5 to 7 PM and are subject to change without notice. Private viewings can be arranged upon request.
